- 7) New Business.
  - a) Discuss OD Issues and measurement
    - The US Class should start keeping a 'measurement database' of all US boats so all paperwork is available 'on the cloud'.
    - Bruce Millar (ICA) has OD stickers, Tony Pocklington also has some for Edge Sailing boats.
    - Gene Hinkel is the only US measurer.
    - Tony Pocklington could also be certified as a US measurer.
  - b) Discuss ways to support new US builder and develop class interest via, marketing, trade shows, etc.
    - Dolly stickers
    - Sell t-shirts: Jay Corcoran has made rash guard shirts with class logo and sail number (if desired).
    - Sell class swag

- No limitation on what the class can do to support Edge Sailing, we have seven boats in Port Charlotte, some of which Dennis has been making available to interested parties.
- Find boats not currently registered with the class
- Class members are encouraged to help build the class by starting local fleets and to demonstrate and promote 2.4mR sailing locally.
- Class should be actively looking to find all boats in USA.
- Establish regattas and a regular calendar of events in various locations

  - Dennis made a motion to have a trial membership for first timers with zero cost when joining late in the year ie last quarter. Tony seconded, vote passed with seven for, one against.
